
The Community Panel has joined with the Friends of Putney Library and the founder of the Repair Café to host a meeting on Thursday 30 March at 5.30pm in Putney Library, Disraeli Road. They call it the 'Circular Economy' - the sustainable world of "reduce, reuse and recycle", but there's not as much discussion about repair. So how can we reduce the ever-increasing tides of waste appliances and clothing going to landfill? The best option is to repair and reuse. Come and hear the founder of Putney's Repair Cafe, Charlie Lindsell, tell the story of how and why it was founded, and how it works. Why repair is essential to keep products in use longer and how we can avoid buying non-repairable products by supporting the repairability legislation soon to come before the UK parliament.

DEFIBRILLATORS SAVE LIVES - Immediate cardio-pulmonary resuscitation (CPR) and defibrillation can help increase someone's chance of survival. Increasingly, GPs are advising you to get hold of a defibrillator before an ambulance arrives.

Last year the long-standing Council air quality monitors situated on the High Street regularly broke down and needed replacing. As an interim measure the Council has installed temporary air monitors so we have reliable NO2 data once again. The medium-term aim is, subject to a procurement exercise, to have brand new monitors in place by the summer which will also record PM 2.5 (particulates) data as well. These monitors will also be supplemented by additional 'Breathe London' monitors. The precise location of these is to be determined but will most likely be close to the most polluted section of the High Street which is outside the cinema and opposite by Simmons bar.

Further to last month's news that the 93 bus is to go electric from 2024, we now understand that the switch may in fact happen much sooner. We have heard reports, still to be publicly confirmed, that new electric buses might begin appearing from this March. The 93 is currently amongst the most polluting bus services operating in Putney so this is very good news. Once fully introduced it would leave the 39

as the only wholly diesel bus using our High Street.

A couple of local transport issues to look out for. There is to be a public meeting on 16 March at Regenerate Rise, 22 Felsham Rd, SW15 1DA, between 7pm-8pm on cycling and walking. It will be a chance to hear about Council plans to make cycling and walking a more pleasant and enjoyable experience in and around Putney High Street especially, but also the wider area. Plans include parallel cycle routes to the High Street. This idea has been mooted for some time so it will be interesting to hear what is being suggested. And a proposal which has been floated for even longer is the current campaign for lifts at East Putney tube. Given TfL's budgetary position and some technical issues regarding the East Putney site, this will require sustained campaigning if it is to be successful. Interestingly, Barnes Station, which is drawing from a different pot of money, is to have three lifts installed in the next 12 months, so if there is the will it can be done.

Over a number of evenings around Chinese New Year, semi-professional grade 3 fireworks were set off in Wandsworth Park. The park is governed by a set of byelaws inherited from the Greater London Council. Paragraph 31 states: "No person shall in any open space, discharge any gun, syringe, squirt, catapult or other instrument, or shall wantonly or recklessly throw or discharge any stone or missile, or make any bonfire or let off any firework." But who is around at midnight to police these byelaws?

The mess left in the park was appalling – many boxes like the one shown and bits of metal from the exploded devices. Debris that is very dangerous for dogs and small children using the park.

The UK law says you must not set off or throw fireworks (including sparklers) in the street or other public places. You must not set off fireworks between 11pm and 7am, except for:

- Bonfire Night, when the cut off is midnight
- New Year's Eve, Diwali and Chinese New Year, when the cut off is 1am

The fireworks set off in the park were a danger to wildlife (the park is home to at least two species of bat) and very

disturbing to local residents and their pets. Do the current regulations covering the sale and use of fireworks take into account the increasing availability of semi-professional fireworks or the proliferation of registered firework sellers?

On a more positive note, the panel is preparing for the 2023 Front Garden Award Scheme – watch this space for news of the dates and locations when we will be giving away plants and advice for residents of central Putney streets.

I ought to start this column by welcoming Sarah Healey as the new Housing Secretary, the sixth within the last twelve months, but by the time you read this it may be too late. Clearly housing isn't actually important in Whitehall, and targets have been dropped from the Levelling Up Bill.

In November 2022, chancellor Jeremy Hunt said £6 billion of spending to improve home insulation would start in 2025. How many years after declaring a Climate Emergency? But at least Mr Gove has announced a ban on artificial grass for new housing estates! Not all MPs are to blame. In January the House of Commons Environmental Audit Committee said that all homes should have an Energy Performance Certificate (EPC) rating of C or above by 2035 – and that by 2025, at least one million homes a year should be installing insulation and other energy efficiency measures. However, the Chancellor will still tax you 20% VAT if you do.

The Mayor of London is making a second staircase mandatory for new flats over 18m high (6 storeys). But beware. One developer told the press 'We're currently designing in second staircases and adding more floors to the towers to compensate.' The Mayor has also published Air Quality Neutral (AQN) guidelines for developers to meet air quality standards set out in the London Plan (2021). But small schemes and developments without additional car parking or new gas boilers – nearly all - are exempt.

Using less gas left redundant the big gas holder between Armoury Way and the railway. Now there's a scheme for 16 storeys of flats following the circle of the gas holder

foundations. And to make up numbers there will also be a 30-storey tower, which will be centre stage in the view from Putney Bridge. All on half the area of vacant land here. We are working with the Wandsworth Society in objecting.

Meanwhile Wandsworth Council deserve recognition for trying to do their bit for energy saving. But your Panel reluctantly found ourselves objecting to a Council scheme to install air source heat pumps, photovoltaic (PV) panels, new windows and upgraded insulation on a school - because this was the Grade II listed Brandlehow School, but the proposals didn't appear to acknowledge this. I have also had to advise one member who had consent for PVs on his house wrongly refused, yet Cambridge Council have agreed to panels on the roof of Grade I listed Kings College Chapel.

I do hope the schools team aren't expecting planning consent in time for the summer holidays. Wandsworth's planning backlog keeps increasing. My own office is still waiting for a simple Permitted Development certificate that's eight weeks late as I write. We had been told that the twin proposals for Putney Pier would be heard at the January Planning Applications Committee, but they have now missed both this meeting and that in February.

Appeals are even slower. When the proposal for an extra floor on Elystan Court was rightly refused last June by Wandsworth's PAC, the owners appealed straight away but have had to wait six months for a Planning Inspector to be allocated.
